- If locomotives needed, then what locomotives are needed and how many for each line. (this information to be submitted to ARS for quoting and lead times)
- If wagons / tankers needed, then what and how many wagons / tankers are needed for each line to achieve client monthly quota. (this information to be submitted to local manufacturing partners for quoting and lead times)
- Once all information as above is gathered and designed according to best practice methods then meetings to provide full breakdown will begin.



- If Operations needed, then what kind of staffing solution is best suited for each project.
- Big Five Rail to be nominated as clients Rail operator.
- Once contract approved and signed off by both party's implementation date will be agreed on.
- Once contract implemented progress to be monitored and necessary adjustments made.
- All staff shall belong to and remain with Big Five Rail (Pty) Ltd for duration of contract, upon date expiration of contract as agreed to prior to signing of contract the client can negotiate the buying out of employee's contracts with Big Five Rail (Pty) Ltd. to remain with client.
